**DECLARATION OF BONNIE
NORMAN**

19 I, Bonnie Norman, testify and declare as follows:

20 1. I am the Petitioner in the above-entitled action, over eighteen years of age,
21 competent to testify to the matters set forth in this declaration, and make this declaration
22 from personal knowledge of those matters.

23 2. I work for Care Innovations as Director of Quality and Regulatory Affairs.
24 Care Innovations offers products and services designed to help the sick and the elderly
25 better manage their day-to-day care.

26 3. I also volunteer as a forum moderator on the Tesla Motors Club website
27 located at <www.teslamotorsclub.com> (the "TMC Website"). The TMC Website
28 provides an online forum for Tesla car owners and enthusiasts to exchange ideas, news

1 and information. The TMC Website is completely unrelated to Care Innovations.

2 4. Occasionally, the TMC Website operators decide to ban users who engage
3 in inappropriate behavior. I am not an owner or operator of the TMC Website. As a
4 moderator, I do not have any authority to ban anyone nor do I have any authority to
5 reverse a ban.

6 5. On October 27, 2013 the Respondent, James Morrison, contacted me by
7 sending me a private message on the Facebook social networking website. In the
8 message, Mr. Morrison accused me of frivolously banning his TMC Website account and
9 told me he would be “escalating the issue” and that “the escalation will be towards your
10 professional career at Care Innovations.” He said I had “a limited amount of time (days)
11 to correct your mistake” otherwise he would retaliate “in a manner that will have an
12 impact on your personal and professional reputation.” A true and correct copy of Mr.
13 Morrison’s messages to me and my responses is attached as Exhibit A to this declaration.

14 6. I responded to Mr. Morrison via Facebook and told him that I did not have
15 any authority to ban accounts. I told him I would be passing along the message to a
16 lawyer. (*See Ex. A.*)

17 7. Mr. Morrison responded via Facebook informing me the promised
18 “escalation” would occur “without further notice”. (*See Ex. A.*)

19 8. I responded to Mr. Morrison via Facebook and asked him why he believed I
20 had attacked him and why he believed I had the power to ban people from the TMC
21 Website. (*See Ex. A.*)

22 9. Mr. Morrison responded via Facebook telling me to “drop the stupid act”
23 and repeating his threat. (*See Ex. A.*)

24 10. I responded to Mr. Morrison via Facebook, asking him to apologize and
25 telling him I did not like being threatened. (*See Ex. A.*)

26 11. Mr. Morrison responded via Facebook that: “There will be no more
27 responses. Escalation is happening. Goodbye.” (*See Ex. A.*)

28 12. At that point I learned from the TMC Website owners that Mr. Morrison

1 was associated with a user account that posted a link to a pornographic website on the
2 TMC Website. Other TMC Website members complained about the post to me, in my
3 role as moderator, and I removed the post and gave the account a negative report, but I
4 did not ban the account. I relayed this information to Mr. Morrison via Facebook. (*See*
5 *Ex. A.*)

6 13. Mr. Morrison responded via Facebook, warning me that I could “expect a
7 near term response that will have an impact on your personal and professional life and
8 future career prospects.” (*See Ex. A.*)

9 14. I responded via Facebook, asking him to stop cyberbullying and threatening
10 me. (*See Ex. A.*)

11 15. Mr. Morrison responded via Facebook, informing me that he also planned
12 to “escalate” against other people connected to the TMC Website. He said that his “next
13 trip to the Los Angeles region will include a visit to them.” (*See Ex. A.*)

14 16. On October 28, 2013 I received a final message from Mr. Morrison via
15 Facebook consisting of the URL: <www.stevebackers.com>. (*See Ex. A.*)

16 17. Steve Backers is Director of Human Resources at my company, Care
17 Innovations.

18 18. When I clicked on the URL <www.stevebackers.com>, I was taken to a
19 website (the “Harassing Website”). The content for the Harassing Website is a message
20 from “Bonne Durand Norman—Director Care Innovations.” The message reads:

21 Steve Backers

22 Child Predator

23 Please be aware that we have a dangerous child predator living
24 nearby.

25 During an unrelated investigation, a large number of images
26 depicting graphic child pornography were found on the computer of Steve
27 Backers.

8 small children living with you or visiting your home.

13 A true and correct copy of a screen capture of the website is attached as Exhibit B
14 to this declaration.

15 19. My maiden name is Durand and I go by “Bonnie Durand Norman” on
16 Facebook to make it easier for old friends to find me. But I did not create the website or
17 any of its content.

18 20. None of the allegations published on the Harassing Website are true and I
19 have never made any of these allegations against Mr. Backers.

20 21. I accessed the publicly available domain registration records associated
21 with the Harassing Website by visiting the website located at <who.godaddy.com>.
22 These records contain the WHOIS registration information associated with the domain
23 name. These records show that the domain name for the Harassing Website was
24 registered on October 28, the day after Mr. Morrison threatened me with “escalation” and
25 “retaliation” and shortly before he sent me the message with the link to the Harassing
26 Website. A true and correct copy of these records is attached as Exhibit C to this
27 declaration.

28 22. Via the website located at <who.godaddy.com> I also accessed the publicly

1 available domain registration records for four additional domain names:

- 3 • <www.marcusgrindstaff.com>
- 4 • <www.jamespursley.com>
- 5 • <www.seanslovenski.com>

6 All four of those domain names correspond to the names of executives and officers at my
7 company, Care Innovations. Eric Dishman is Director of Health Policy. Marcus
8 Grindstaff is Director of Strategic Planning and Product Management. James Pursley is
9 Vice President of Sales & Marketing. Sean Slovenski is Chief Executive Officer. The
10 records associated with each domain name show that they were registered at the same
11 time that the Harassing Website was. True and correct copies of these records are
12 attached as Exhibits D-1 thru D-4 to this declaration.

13 23. Prior to his threatening message, I had never heard of Mr. Morrison. I have
14 no idea how he managed to find my personal Facebook page or the company where I
15 work. I also have no idea how he managed to find Mr. Backers' home address.

16 24. Based on Mr. Morrison's threatening messages, his attempts to extort me,
17 his promise to "escalate" matters, the creation of the Harassing Website, his announced
18 plans to visit the Los Angeles area, and the registration of domain names of the people I
19 work with, I am seriously alarmed, annoyed and harassed and have suffered substantial
20 emotional distress.

21 25. I am afraid of what Mr. Morrison might do in the future. He knows where I
22 work, and if he could find Mr. Backers' home address, then I am sure he could find mine
23 as well.

24 26. On the advice of security specialists, my company has hired a security
25 guard. He meets me at my car in the parking lot and walks me into the office then
26 remains at the door for the entire day before walking me back to my car when I leave.
27 Even so, I find myself scanning the parking lot when I pull into work and when I leave to
28 see if I'm being followed.

1 27. I live alone in a rural area. A few of my neighbors found out about this and
2 they distributed photos of Mr. Morrison to everyone in our area so that people could keep
3 an eye out for him in case he decides to escalate things even further. My neighbors also
4 check my home to confirm it is safe before I enter. I've already consulted with several
5 friends in law enforcement about my personal safety. On their advice I have literally been
6 sleeping with a loaded gun—before this incident it almost never left my gun safe. The
7 last three nights I have slept with all of the outside flood lights on. Each night I wake up
8 about a dozen times.

9 28. Emotionally, I feel very upset. I feel victimized and I hate being a victim. I
10 hate what this has done to me. It is embarrassing for me personally and professionally. At
11 work, I feel embarrassed that I am somehow causing a disruption. And I feel wretched
12 that Mr. Morrison has targeted my friends and coworkers reputations in order to harass
13 me. Every time my phone pings I get a sick feeling wondering if it's him contacting me
14 again with another website defaming someone I care about. I feel terrorized and I want it
15 to stop.

16 29. I want Mr. Morrison to stop harassing me—directly or via attacks on my
17 friends and coworkers. Unless Mr. Morrison is restrained from continuing his harassing
18 conduct, I will continue to suffer irreparable harm.

20 I certify and declare under the penalty of perjury under the law of the State of
21 Washington that to my knowledge the foregoing is true and correct.



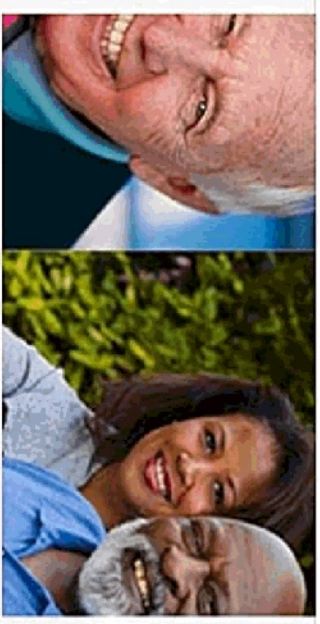
